WHAT WILL YOU BE DOING IN THIS POSITION?

The Philanthropy Advisor is responsible for implementing key parts of the Philanthropy Program with a particular focus on forming new relationships with philanthropists, high-net-worth individuals, and trusts & foundations. Working with the Associate Director of Giving and the Philanthropy team, this role will contribute to the Philanthropy Strategy. The role will work with the Philanthropy team, to identify, qualify, cultivate, and solicit new philanthropic relationships and expand Philanthropy income.

Strategy, Budgeting and Planning

- Work with the Philanthropy Lead to input into the Philanthropy strategy
- Work with Philanthropy team to execute the Philanthropy strategy
- Design and implement an acquisition plan for identifying, qualifying, cultivating and soliciting new Philanthropic relationships and funding
- Collaborate with Philanthropy Advisor Major Donors to align strategies to co-create overall Philanthropy strategy, and contribute to design and implementation of retention and upgrade strategy for existing major donors and prospects
- Contribute to Giving Team Strategy

Philanthropy

- Secure significant financial gifts to support the work of Plan ideally in the 6-figure realm
- Work closely with Prospect Researcher to identify new philanthropic prospects to qualify, cultivate, and solicit, including systematic pipeline management of 200-300 T&F and PAF prospects identified through external prospect research
- Develop a personalised communications plan for each new prospect. The communications plans may include 1-1 solicitation and stewardship, personalised mail, email, phone contact, and the preparation of individual proposals and acquittals, and events. It may also include the direction of mass communications channels, bespoke updates and large-scale stewardship opportunities (e.g. Christmas Cards).
- Support the Philanthropy Advisor Major Donors in the growth of Girls Education & Empowerment Fund (GEEFund) product and journey, including (but not limited to) Impact Report publication, cultivation events, internal stakeholder management, product refresh etc
- Deliver on solicitation plans to acquire, retain, upgrade and reactivate donors.
- Co-design and implement robust CRM processes for prospect and pipeline management
- Maintain accurate pipeline reporting and donor records in database.
- Develop strong working relationships with internal program stakeholders (in Australia and globally) to develop appropriate philanthropic offerings.
- Proactive cultivation of sector relationships to identify new markets and communities that could help us achieve philanthropic goals, including attendance at appropriate networking opportunities.

Giving Team Outcomes

- Actively participate in the giving team culture
- Collaborate across programs to help achieve strategic outcomes
- Collaborate and co-design strategies with Partnerships and Mid Value to achieve OKR strategic outcomes and unified donor stewardship across all programs
